CEO CORNER

In January, BENCO Electric Cooperative's Board of Directors approved a capital credit refund of approximately \$1.6 million to its membership in March.

The refund is coming from two sources:

- BENCO is returning an estimated \$785,600 based on the dollar amount of energy purchased during portions of 2005 and 2022. This refund is possible due to BENCO's strong overall financial position.
- Great River Energy and SMEC, BENCO's wholesale power providers, are also returning \$840,000 of capital credits based on the dollar amount of energy purchased from these organizations.

Remaining profits (or margins) collected after expenses are returned to the membership for purchasing electricity during the years being retired. Active members will receive a check in the mail if their refund is \$10 or more, unless they have opted to receive a bill credit. Members whose refund is under \$10 will automatically receive a bill credit. Inactive members (those who have moved off BENCO's system) will be mailed a check to their last known mailing address.

BENEFITS OF MEMBERSHIPWhy do co-ops issue capital credits? Capital credits are a

membership benefit of being served by a cooperative like BENCO. Unlike for-profit companies, co-ops do not operate to build shareholder wealth. Member equity is created when any earnings (revenues minus expenses) are left over at the end of each year. This creates a margin.

When financial conditions allow, BENCO will use a proportional ratio to return any extra margins back to the members based on the dollar amount of energy purchased in a given year. Before returning the margins, BENCO uses the capital to help offset the cost of debt for construction and maintenance of the electric distribution system. This helps lower financing needs and represents your ownership equity in the cooperative.

SAFETY FIRST: 10 DO'S AND DON'TS WHEN USING PORTABLE GENERATORS

With proper use and maintenance, portable generators can provide great convenience during an outage. However, when generators are used incorrectly, they can be extremely hazardous. If you're planning to use a portable generator in the event of an outage, BENCO Electric Cooperative reminds you to play it safe.

In a 2022 report, the Consumer Product Safety Commission estimated 85 U.S. consumers die every year from carbon monoxide (CO) poisoning caused by gasoline-powered portable generators.

Here are 10 do's and don'ts to keep in mind when using portable generators:

- 1. DO: Install backup CO alarms.
- **2. DO:** Keep children and pets away from portable generators at all times.
- 3. **DO:** Position generators at least 25 feet outside the home, away from doors, windows and vents that can allow CO to enter the home.
- 4. DO: Ensure your generator is properly grounded. Use a portable ground fault circuit interrupter (GFCI) to prevent electric shock injuries.
- 5. DO: Use three-pronged extension cords that are rated to handle the load of the generator. Inspect extension

cords for cuts, frays or other damage before use.

- 6. DON'T: Operate a generator inside your home or an enclosed (or partially-enclosed) space. Generators produce high levels of CO, which can be deadly.
- **7. DON'T:** Open windows or doors while the generator is running.
- **8. DON'T**: Rely on generators as a full-time source of power. They should only be used temporarily or in emergency situations to power essential equipment.
- DON'T: Overload generators.
 Ensure your generator can handle the load of the items you plan to power.
- 10. DON'T: Connect generators directly into household wiring unless you have an appropriate transfer switch installed. If a generator is connected to a home's wiring without a transfer switch, power can backfeed along power lines and electrocute utility lineworkers making repairs.

While generators provide convenience during power outages, they can quickly become hazardous if improperly operated. Before you operate a portable generator, be sure to thoroughly read the owner's manual for important safety information and tips.




GOING THE EXTRA MILE


BENCO ELECTRIC COOPERATIVE SERVES 5.48 MEMBERS PER MILE OF LINE
