

## **OPERATION ROUND UP GRANTS OVER \$28,000**



The Operation Round Up Trust Board gathered in September when 17 grants, totaling \$28,030.00 were awarded to the following non-profit organizations: Kiester Library, Wishes & More, Nicollet Public School,

Kiester Fire Relief Association, Mapleton Fire Department, Mankato & North Mankato ACT on Alzheimer's, Friends of Learning Back to School Project, Echo Food Shelf, Feeding Our Communities Partners (FOCP), Faribault County Food Shelf, Janesville Food Shelf, Kiester Food Shelf, Lake Crystal Area Food Shelf, Maple River Loaves and Fishes Food Shelf, St. Peter Food Shelf, Wells Area Food Shelf and the Winnebago Food Shelf.

Operation Round Up is an organization through BENCO Electric Cooperative where members' utility bills are rounded up to the nearest dollar. The "rounded up" amount goes into the BENCO Electric Cooperative Trust that is then allocated to non-profit organizations throughout the year. The non-profit organizations receiving grants are organizations that impact people within the BENCO service territory.

Since the program's inception in 2002, Operation Round Up has donated over \$368,000 to organizations benefitting the BENCO service territory. BENCO members serving on the Operation Round Up Trust Board include:



Echo Food Shelf was an Operation Round Up receipient in September. The organization aims to provide food to over 120 Blue Earth and Nicollet County families on a daily basis.

## **CEO CORNER**

As the 2023 construction season comes to a close, I would like to reflect on BENCO's very successful construction season that included many upgrades and new lines.

We continue to see development in residential, commercial and agricultural services. This year we installed 20 three-phase transformers. This is attributed to new services and many service upgrades.

Construction of the new Rush River substation is nearing completion. This new substation will add necessary capacity, reliability, sustainability and new technologies to the northern area of our service territory.

Some larger construction projects include Nicollet County Road 15 where crews transferred eight miles of overhead lines to underground. In Blue Earth County, crews worked to convert three miles of

single-phase lines from overhead to underground on County Road 16. Our line crews also worked on extending and adding three-phase lines by the southern most point of our service territory, near the lowa border. Crews have also begun a project for next year on Blue Earth County Road 13 near Good Thunder.

Overall, we have installed over 100 miles of underground cable this year.

# NOTICE OF RIGHTS FOR HOUSEHOLDS OF MILITARY SERVICE PERSONNEL

An electric cooperative cannot disconnect a residential customer for nonpayment of electric bills if a member of the household has been issued orders into active duty, for deployment or for a permanent change in duty station during the period of active duty, deployment or for a permanent change in duty station, if such a residential customer meets income criteria specified by law. To receive this protection from disconnection, the residential customer must request and reach agreement with the cooperative on a payment plan.

Verification of income is required unless the member is automatically eligible for protection against disconnection as a recipient of any form of public assistance including energy assistance that uses income eligibility in an amount at or below the income eligibility.

The member has the right to appeal when the utility and residential customer are unable to agree on the



establishment, reasonableness or modification of a payment schedule, or timeliness of payments under a payment schedule.

If denied, an appeal must be made within seven working days after the utility has deposited first class mail notice. Service cannot be disconnected during an appeal.

#### PEACH REFRIGERATOR DESSERT

#### **Crust Ingredients:**

- 1/2 C butter 1 C flour
- 1/2 C chopped nuts 1/4 C brown sugar

#### **Crust Directions:**

Blend and pack the ingredients in a 9x13 pan. Bake 8 - 10 minutes at 400 degrees. Cool.

#### **Filling Ingredients:**

- 1 large pkg. vanilla pudding (not instant)
- 1 large peach jello 4 C water
- 8 oz. Cool Whip 3 4 peaches sliced



#### **Directions:**

Combine jello, pudding and water. Cook until clear. Cool until it begins to thicken like jello. Fold in Cool Whip and add peaches. Pour over crust. Can add a little sugar if using fresh peaches. If using canned peaches, drain before adding. Refrigerate for several hours.
